**AGREES** to defend; indemnify and hold harmless Buffalo Bills LLC, County of Erie, Erie County Stadium Corporation, Orchard Park Chamber of Commerce, Orchard Park Festival of the Arts, Town of Orchard Park, SUNY Erie Community College and Town of Hamburg its members, officers, Directors, employees and agents from any and all claims, suits, liabilities, causes of action, judgments, costs (including, but not limited to, all reasonable expenses of defense and related investigation), expenses, and damages (including damages for care and loss of services because of bodily injury, sickness or disease, including death resulting there from) sustained by User or any person or persons, and because of injury to, or destruction of, property (including the loss of use thereof), caused by, arising out of, or resulting from, in whole or in part, any act or omission of User, its agents, servants, employees or individuals participating in User’s use of the facilities and surrounding areas; and the User further hereby

**AGREES**, On User’s behalf and on behalf of User’s insurance carrier, to waive any rights of subrogation against Buffalo Bills LLC, County of Erie, Erie County Stadium Corporation, Orchard Park Chamber of Commerce, Orchard Park Festival of the Arts, Town of Orchard Park, SUNY Erie Community College and Town of Hamburg that may otherwise attach to or derive from any policy of insurance the User may obtain to insure against User’s liability in connection with use of the facilities and surrounding areas, and the User further hereby

**AGREES**, to name Buffalo Bills LLC, County of Erie, Erie County Stadium Corporation, Orchard Park Chamber of Commerce, Orchard Park Festival of the Arts, Town of Orchard Park, SUNY Erie Community College and Town of Hamburg as an additional insured on any and all insurance policies User may obtain in connection with use of the facilities and surrounding areas.
