LOCATION: We will be setting up spaces based on the size restrictions as well as any regulations that are in place by New York State at the time of the festival. All of the spaces will be outdoors on the pavement of the Buffalo Bills parking lot. Each exhibitor will have the same size area, unless you choose multiple spaces. If you have a trailer that can be stationary for the entire event, you may request in advance to park it in a designated space in the exhibit area. We will not be using any buildings during the event.

• Photo 1 must be of the Exhibitor(s) who will be participating in the Festival.
• Photos 2 & 3 must be of the exhibitor creating/ building art/craft (e.g., exhibitor making the art/craft in their workshop.)
• Photo 4 must provide a picture of your actual exhibit booth display.
• Photos 5 – 7 must show the types of work to be displayed.
